## WILDLIFE PROTECTION POLICY

The commitment to the preservation of biodiversity in the areas of our activities, is one of the essential elements that integrates and inspires the corporate policy of Candente Copper Corp. ("DNT"), Candente Gold Corp. ("CDG") and Cobriza Metals Corp. ("CZA") (jointly "the Companies") and their subsidiaries. For this reason the Companies consider it is necessary to publish the basic guidelines of the Wildlife Protection Policy.

As measures to protect the local flora and fauna in the areas of our activities, the Companies and their subsidiaries declare that:

- The introduction of exotic species in the areas of the Companies projects (the "Projects"), whose presence may harm existing native species through changes in the natural condition of ecosystems is forbidden.
- The natural environment of all flora and fauna species of ancestral value to the communities and to the Peruvian State, which may be affected by the Companies activities, will be protected and preserved to the greatest possible extent.
- Fishing, hunting, killing and capturing specimens of fauna and the destruction and/or collection of specimens of flora in the areas of activities are forbidden, except when carried out by the relevant government authorities, for scientific research or any type of work related to the Projects, provided they are duly authorized by government authorities.
- It is prohibited to buy, to propose to purchase, to acquire for commercial purposes, to use for commercial gain, to sell, to keep in captivity with a view to sell, offer for sale or to transport for sale purposes any specimen in the areas of our activities.
- Training, through regular talks and workshops, is provided to all Projects personnel, in order to emphasize the importance of protecting local biodiversity.
- Recognition and protection of property rights and traditional knowledge and practices of the rural communities in relation to biodiversity has been established.
